



**Sunil Shah** is a Consultant Ophthalmologist at the Birmingham and Midland Eye Centre, City Hospital Birmingham and a Honorary Consultant at Birmingham Children's Hospital. He is also an Honorary Professor at The University of Ulster and a Visiting Professor at Aston University, Birmingham. He specialises in complex corneal and refractive surgery. He independently developed the laser eye surgery technique now called laser-assisted sub-epithelial keratectomy (LASEK) and was the first person to use it in the UK and continues to pioneer this technique. He has had over 150 articles published in peer-reviewed journals, as well as various book chapters. Professor Shah is on the Editorial Board for *Ophthalmology Times* and *European Ophthalmic Review* and is past Section Editor for the *British Journal of Ophthalmology*. He is an Editor and E Tutor for the E-learning course in refractive and cataract surgery for the University of Ulster. He is an Examiner for The Fellowship of the British Contact Lens Association and also for the Refractive Assessment for the Royal College of Ophthalmologists. Professor Shah is past President of the British Society for Refractive Surgeons and was a Member of Council for The British Contact Lens Association.

**T**he current issue of *European Ophthalmic Review* presents a stimulating mix of expert reviews, case studies and reportage from the ophthalmology society meetings.

Satellite symposia reports feature the subjects of aflibercept in diabetic macular oedema (DMO) (Korobelnik et al.) and DMO management, in particular relating to corticosteroid use (Augustin et al.) Quhill and Paulo and Eckardt describe important case studies on the effectiveness of the ILUVIEN implant in DMO patients in whom therapy with ranibizumab did not result in sustained improvements.

Diagnosis, management and future objectives in severe dry eye disease are outlined by van Setten et al. while Packer et al. review the state-of-the-art LENSAR<sup>®</sup> Laser System in femtosecond cataract surgery. Robotic systems to assist in ophthalmic surgery is another surgical focus and Nelson et al. call attention to recent progress in magnetically actuated microrobotics for ophthalmic therapies. Improvements in glaucoma treatment and the importance of preservative-free medications are underscored by Traverso et al., and Mosaed presents the primary outcome results of the global Trabectome experience. Willoughby looks at early detection of Fabry Disease and the important role of ophthalmology.

A review by Michalewska et al. highlights the contribution and potential of a new non-invasive imaging technique, swept source optical coherence tomography, in improving our understanding of choroidal anatomy and function in a variety of retinal and chorioretinal diseases.
